Please be advised that Millennium Global Holdings, Inc. (the "Company" or "MG") executed the following agreements today:

- a. Investment Agreement with CHEN CHIH-HSING amounting to PHP15,000,000, payable to CHEN CHIH-HSING in 3 years from execution of the Agreement, convertible into equity at the option of CHEN CHIH-HSING and subject to extension of time as may be mutually agreed upon by the parties;

- b. Subscription Agreement with CEBU CANNING CORP. (“C3”) for the subscription to PHP3,700,000.00 worth of C3 primary common shares equivalent to 37,000 primary common shares at par value of PHP100.00 per share; and
- c. Subscription Agreement with C3 for the subscription to PHP3,000,000.00 worth of C3 primary common shares equivalent to 30,000 primary common shares at par value of PHP100.00 per share, to be taken from an increase in authorized capital stock, subject to approval by the Securities and Exchange Commission (“SEC”) of the Philippines.


The execution of the Subscription Agreements with C3 is pursuant to the plan to fully acquire C3 as a wholly-owned subsidiary of MG. C3 will become MG’s subsidiary (51%) upon approval by the SEC of C3’s increase in authorized capital stock. The completion of the acquisition of C3 (100%) will take place upon transfer of all the C3 secondary shares to MG.
