Under the agreement, the Company subscribed to One Hundred Thirty Seven Million Nine Hundred Eight Thousand One Hundred Sixty Three Pesos (P137,908,163.00) worth of primary common shares of MOSC at par value of One Peso (P1.00) per share.

MOSC is primarily engaged in the processing of high quality seafood and aquaculture products for export and trading of imported marine and other related products. Its key business activity is the processing and export of several quality and high valued seafood products such as Black Tiger Shrimps, Kisu (asohos) fillet, frozen lobsters, etc.

Its processing plants and buying stations are strategically located all over the country, enabling it to have a strong market foothold in Japan, Taiwan, Hong Kong, Vietnam, Malaysia, Singapore, United States of America, Canada, etc.


